In DMVA News, Governor Wolf announced a Veterans' Trust Grant Opportunity. The Veterans' Trust Fund (VTF) is accepting grant applications for programs and services benefiting Pennsylvania veterans. The Department of Military and Veterans Affairs (DMVA) will award up to \$800,000 in VTF grants to non-profit organizations, veteran service organizations and county directors of veteran affairs across the state. Updates from Doc Maher:

 Activity has been underway at the VA since October to develop plans to deliver a COVID-19 vaccine. The DOD moved quickly to ensure a safe and effective rollout of the first COVID-19 vaccine, and began with frontline healthcare workers, and first responders, since initial allocations of the vaccine were delivered beginning December 14th. 13 military communities in the US received their vaccine doses on time and within 24 hours of receipt, they began administering the vaccine. Partial list of initial 13 communities include: Wilford Hall Ambulatory Surgical Center at Joint Base, San Antonio-Lackland Texas, Navy Medical Center Portsmith Virginia, Walter Reed National Military Medical Center in Bethesda Maryland.

VA will begin Moderna and Pfizer COVID-19 vaccinations this week at 128 additional sites, including CVAMC

- Due to COVID-19 exposures, the National Personnel Records Center (NPRC) has informed the National Cemetery Administration that they have shut down most of their remaining operations indefinitely, thus negatively impacting the ability to obtain documents to determine eligibility for interment at national cemeteries.
- VA's Blue Button feature on the MyHealthVet site

reached its 10-year anniversary. The feature makes it easier for Veterans to access their EHRs (electronic health records) and download copies and personnel medical history information including lab reports, images, VA prescriptions, appointment logs, and emergency contact info. You can go to www.myhealthvet.va.org to search for more info regarding Blue Button.

 The VA Debt Management Center will resume sending out "due process notification letters" in January 2021 for those with outstanding VA benefit debts. The notices are to start after 1/1/21 and should include your options. If you expect problems with this, you can request info and help at www.va.gov/debtman or call 1-800827-0648. Input received from Ken Schweitzer. 1st Vice President: SEVC report on COVID-19. 16 staff tested positive, all with no symptoms, quarantining at home. Also 6 residents tested positive and are in isolation, separated from other residents. As of this printing, the center is awaiting the vaccine schedule.

Holiday celebrations are quite different this year due to COVID, as no outside visitors are permitted. The staff is decorating the facility in a holiday theme to help lift the spirits of all. A holiday parade was held on December 20th with family, National Guard, First Responders, participating, waving and cheering at the residents from outside. All admissions are halted due to the virus, and plans for admitting new residents are being discussed at this time.

According to the DVA, veterans who typically pay for their medical care, may be hit with a big bill in January after the VA halted all collections in April 2020, including those copays. The copay bill letter, the VA warned in a December 17 announcement, will ask the recipient to pay for all "new copay charges for medical care and prescriptions they received from April 6, 202 through December 31, 2020." It also said, the bills could also include unpaid amounts for care received before April.

Many military personnel, their families and veterans would be eligible for one-time stimulus checks of \$600 under the \$1.4 trillion federal funding package and coronavirus relief bill released by Congress on Monday.

The proposal calls for direct payments of \$600 to eligible Americans, plus \$600 per dependent child. Under the plan, those earning up to \$75,000; \$112,500 as head of household; or \$150,000 as a married couple filing jointly, qualify for the full payment.
